TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE SECURITY COUNCIL FOR THE MONTH OF APRIL 2012

AFRICA

Central African Region – United Nations Office for Central Africa (UNOCA) Letter from the President of the Security Council dated 30 August 2010 (S/2010/457) Proposed that the office be established for an initial period of two years, with a <u>review of its</u> mandate after 18 months.

Côte d'Ivoire

Resolution 2000 (2011) of 27 July 2011

Para. 19: requests the Secretary-General to submit to it, through the midterm report referred to in paragraph 18 above or through a special report no later than 31 March 2012, taking into account the holding of the upcoming legislative elections as well as the prevailing security challenges and progress in rebuilding national capacities, recommendations on possible adjustments in UNOCI's structure and strength.

The report of the Secretary-General dated 29 March 2012 (S/2012/186) is before the Security Council.

Côte d'Ivoire – sanctions

Resolution 1980 (2011) of 28 April 2011

Para. 1: decides to renew until 30 April 2012 the measures on arms and the financial and

measures of the sanctions regime, in accordance with progress in the peace process, the developments related to Human rights violations and the developments related to the parliamentary elections.

The review of the sanctions measures is expected to be held by 30 April 2012.

Para. 13: decides to extend the mandate of the Group of Experts as set out in paragraph 7 of resolution 1727 (2006) <u>until 30 April 2012</u> and requests the Secretary-General to take the necessary measures to support its action.

The mandate of the Group of Experts will expire on 30 April 2012.

Para.14: requests the Group of Experts to submit a midterm report to the Committee by 15 October 2011 and to submit a final report as well as recommendations to the Security Council through the Committee <u>15 days before the end of its mandated period</u>, on the implementation of the measures imposed by paragraphs 7, 9 and 11 of resolution 1572 (2004), paragraph 6 of resolution 1643 (2005) and paragraph 12 of resolution 1975 (2011).

The final report of the Group of Experts is expected to be before the Security Council by 15 April 2012.

Liberia - UNMIL

Resolution 2008 (2011) of 16 September 2011

Para. 15: requests the Secretary-General to keep it regularly informed of the situation on the ground as Liberia enters this next critical phase, and to provide <u>by 30 April 2012</u> a report on the issues addressed in paragraphs 2, 5, and 7, including recommendations for appropriate Security Council action, and expresses an intention to consider these recommendations in a timely manner.

The report of the Secretary-General is expected to be issued by 30 April 2012.

The Sudan – UNISFA

Resolution 1990 (2011) of 27 June 2011

Para 11: requests the Secretary-General to keep the Council regularly informed of the progress in implementing the Agreement and to report to the Council <u>no later than thirty days</u> after the adoption of this resolution and <u>every 60 days thereafter</u>.

Resolution 2024 (2011) of 14 December 2011

Para 5: requests the Secretary-General to keep the Council informed of progress in

Resolution 1979 (2011) of 27 April 2011 Para. 13: decides to extend the mandate of the United Nations Mission for the Referendum in Western Sahara (MINURSO) until 30 April 2012.

The MINURSO mandate will expire on 30 April 2012
